## 1. Humanwell Healthcare (Group) Co. Ltd

Established in 1993 (listed in the Shanghai Stock Exchange), Humanwell Healthcare is the first private high-tech listed enterprise. It occupies a leading position in anesthetics/analgesics, fertility regulation drugs, Uyghur medicine and other segments. The company has set up R&D centers in the US, and acquired companies such as EpicPhama, Ansell and Ritedose. Their overseas business revenue accounts for 30% of its total revenue.

*Business Objectives:* Humanwell Healthcare wants to set up R&D and sales centers in the European market, focusing on following product areas: anesthetics (search for new varieties, equity cooperation); fertility regulating drugs; biological products; in vitro testing; blood products.
