# BIOGRAPHIES



## HIS MAJESTY THE KING

## HISTORY

His Majesty the King was born in Brussels on 15 April 1960. He is the eldest son of King Albert II and Queen Paola and the grandson of King Leopold III and Queen Astrid.

Following the abdication of his father, King Albert, Prince Philippe was sworn in before the combined chambers of parliament on 21 July 2013 as the seventh King of the Belgians.

He married Mathilde d'Udekem d'Acoz in 1999.

Prince Philippe was educated bilingually (in Dutch and French) at Belgian state primary and secondary schools, and then at the Belgian Royal Military Academy, a bilingual higher education establishment. Inspired by a passion for flying and space adventure since childhood, he chose to join the Air Force, where he qualified as a fighter pilot. He completed his military training with the paracommando course. He then left Belgium to continue his academic studies abroad. After one term at Trinity College, Oxford (United Kingdom), he spent two years at Stanford University in the USA, where he graduated with an MA in Political Science.

Returning to Belgium in 1985, he began to learn about his country's political, social and economic realities. Over the next eight years he got to know Belgium and its people through numerous visits, meetings, conferences and missions. This gave him a thorough understanding of the country and its workings.

Also during this time, the young Prince Philippe acquired an in-depth knowledge of areas of particular personal interest, such as history, literature and philosophy. His study tours enabled him to meet all kinds of committed people, both leaders and ordinary citizens. He also closely followed the European integration process. In addition, he gained various experiences in the humanitarian field.

The death of King Baudouin in 1993 marked a turning point in the Prince's life. Following the accession of his father King Albert II, Philippe became heir apparent to the throne at the age of 33.

From this time on, his public role became established. In line with the major issues of the time, his main areas of involvement were international missions to promote the Belgian economy and Belgium's image abroad, sustainable development, dialogue between Belgium's various communities, support for vulnerable people and the nurturing of talent. Prince Philippe engaged in close dialogue with politicians, granting them audiences and working alongside them on missions and other activities. Prince Philippe took over the Honorary Presidency of the Belgian Foreign Trade Agency (BFTA) in 1993. In this capacity, he led 85 economic missions abroad over the next 20 years. He built bridges between Belgian and foreign companies as well as between Belgian companies. Following his accession to the throne in 2013, he has remained Honorary President of the BFTA but has asked his sister Princess Astrid to represent him on economic missions.

Another of Philippe's primary concerns is sustainable development. From 1993 to 2013, he was Honorary Chairman of the Federal Council for Sustainable Development, which brings together economic, social, environmental and scientific bodies from around the country to formulate recommendations to the federal government. In the same vein, he also agreed to become Honorary President of the International Polar Foundation. He has been active in supporting dialogue between Belgium's three language communities of French-, Dutch- and German-speakers. The Prince Philippe Fund was set up in 1998 to promote dialogue between citizens from the different communities, in order to foster greater mutual recognition and respect for their individual identities and cultures.

Aware of the many possible forms of marginalization, the King takes every opportunity to meet with its victims. Here too, he experiences human frailty at first hand, whether it is caused by illness, social exclusion, accidents or natural disasters.

The King supports Belgian talent in all its manifestations, including sportsmen and women, artists, scientists, explorers and gifted young people, and follows them all with great interest. King Philippe and Queen Mathilde combine their family life with ceremonial and official duties. They personally supervise the education of their four children, Elisabeth, Gabriel, Emmanuel and Eléonore. The children enjoy a multilingual upbringing and attend school in Dutch.

Holidays are spent with family and friends. In their free time, the King and Queen enjoy reading and playing sport. The King goes running regularly and took part in the Brussels 20km race in May 2013 and 2014.



## HER MAJESTY THE QUEEN

## HISTORY

Her Majesty the Queen was born in Uccle on 20 January 1973. She is the daughter of Count and Countess Patrick d'Udekem d'Acoz.

She attended primary school in Bastogne and secondary school in Brussels, before studying speech therapy and psychology. The Queen worked as a speech therapist from 1995 to 1999.

She married Prince Philippe on 4 December 1999 and they have four children: a daughter Elisabeth (2001), now Duchess of Brabant, two sons Gabriël (2003) and Emmanuel (2005), and another daughter Eléonore (2008). As the mother of four young children, the Queen attaches great importance to her family.

The Queen assists the King in carrying out his functions as Head of State. These include numerous visits to institutions, contacts with the population, ceremonies in Belgium and abroad, state visits, promoting Belgium's image abroad, audiences with representatives of various groups in society and countless trips all over the country. Apart from her activities in the company of the King, the Queen also devotes time to issues that are close to her heart. She regularly visits social institutions and medical centers. These contacts help her to stay in touch with the people and their needs and requirements and with the many initiatives undertaken in Belgium to help others. The Queen attaches a great deal of importance to close contact with the population.

The Queen deploys the Queen's Charities to offer help to citizens who are struggling to cope with financial hardship in their daily lives and often turn to her as a last resort. She takes part in the social debate on subjects of relevance to the population. She has a particular concern for vulnerable people. As Honorary President of the Queen Mathilde Fund, the Queen endeavours to assist the weakest members of our society. The Queen is also concerned with a range of social issues including education, child poverty, intergenerational poverty, the position of women in society and literacy.

The Queen is Honorary President of Child Focus, Foundation for Missing and Sexually Exploited Children. Children's well-being is for Her a fundamental principle and she dedicates herself in the fight against disappearances and all forms of sexual abuse.

The Queen is Honorary President of UNICEF Belgium and of the Breast International Group (a non-profit organization for academic breast cancer research groups from around the world). She was the World Health Organization Europe's Special Representative for Immunization. As from 2014 the Queen has given Her High Patronage to the International Queen Elisabeth Music Competition founded in 1937 as an initiative of Her Majesty Queen Elisabeth and Belgian composer and violinist Eugène Ysaÿe.

In 2016, the Queen was invited by the UN Secretary General to join the Sustainable Development Goals (SDGs) Advocacy Group. This group of 17 eminent personalities supports the United Nations Organization in mobilizing the international community to take action to achieve the SDGs by 2030. The Queen received the Honorary National German Sustainability Award 2017 for her years of social and humanitarian commitment as well as her contribution to the debate on the implementation of the UN Sustainable Development Goals. The Queen is a member of the Schwab Foundation Board for Social Entrepreneurship. She was a United Nations Emissary for the International Year of Microcredit 2005, which focused in particular on financial inclusion and financial literacy. The Queen also attends the annual World Economic Forum in Davos.

Belgian development cooperation is an important issue for the Queen. She has undertaken a number of humanitarian missions, highlighting areas such as children's rights, health issues, poverty reduction, education, good governance, the empowerment of women, HIV/AIDS and orphans (UNICEF/UNAIDS), and non-communicable diseases. The Queen is a great believer in lifelong learning and as one of the World Economic Forum's Young Global Leaders has attended a number of leadership courses at the Harvard Kennedy School and Yale University.

Besides Dutch and French, the Queen speaks English, Italian and some Spanish.

The Queen has a broad interest in art and dance. She likes modern as well as classical music and plays the piano. She also loves literature. She is a keen cyclist, tennis player and swimmer, and enjoys nature and outdoor activities.

### **POLITICAL CAREER**

Starting out his professional career as a lawyer and solicitor, Geert Bourgeois first acceded to politics in 1977, after having spent more than ten years at the service of the 'Vlaamse Beweging' (Flemish movement). He was first elected local councillor for the Volksunie party in Izegem before moving on to become alderman in this town. In 1995, he entered the Belgian House of Representatives, where he distinguished himself as a legal specialist. In 2000 he came at the helm of the Volksunie. After the break-up of this party, he founded the Nieuw-Vlaamse Alliantie (N-VA) in 2001 and became the party's first leader.

Geert Bourgeois is Minister-President of the Government of Flanders, in which he is also competent for foreign policy and immovable heritage.

Geert Bourgeois has been a minister in the Government of Flanders since 2004. Over the years, his portfolio has included local and provincial government, public governance, foreign policy, civic integration, media, tourism, immovable heritage and the 'Vlaamse Rand' (ring of Flemish municipalities around the capital Brussels). In 2009, he became Vice-Minister-President. He has been Minister-president of the Government of Flanders since 2014.



## HE RUDI VERVOORT MINISTER-PRESIDENT OF THE BRUSSELS-CAPITAL REGION

Born on November 20<sup>th</sup>, 1958

- Born on 20 November 1958 to a Dutch-speaking father and a Frenchspeaking mother, Rudi Vervoort is what is typically called a "zinneke" [a person of mixed origin]. From a very young age, he followed current events and the political debate with passion thanks to his subscription to the daily Le Soir, which he asked his parents to get for him when he was in his teens. This enthusiasm for public affairs led him in particular to become president of the "Cercle de Droit" [Law Union] at the French-speaking Free University of Brussels (ULB) when he was a student. His political commitment then came naturally, because "when you study law, you understand very guickly the left/right stakes." Rudi became a member of the Socialist Party at the age of 22.
- In 1989, he was elected municipal councillor in Evere, the municipality where he grew up and where he still lives. An alderman in 1993, he exercised his duties in sport, education, culture, then finance, before becoming mayor in 1998.
- In 1999, he was elected regional deputy and entered the Brussels Parliament. At the same time, he

assumed the leadership of the Socialist Party group, which would drive him to defend and to turn the values of the Socialist Party into concrete measures for the benefit of our Region and its inhabitants. He was also a member of parliament in the Wallonia-Brussels Federation from 2004 to May 2013.

- In 2004, Rudi was elected Vice-President of the Brussels Federation of the Socialist Party and succeeded Philippe Moureaux.
- A pragmatic politician, he led the municipality in particular with the Dutch-speaking liberals. During the last municipal elections, he invited Guy Vanhengel (Open VLD) to appear alongside him on the Mayor's List.
- The ever quiet and thoughtful appearance hides a devotee of the pleasures of life. A lover of good food and an unconditional fan of classical and contemporary rock music (Rolling Stones, Led Zeppelin, Radiohead, dEUS,...), Rudi attends various festivals every year such as Rock Werchter. He is also a nature lover and a touring enthusiast. He climbed Mount Kilimanjaro in 2009. The father of three children, Rudi Vervoort is

married to Nathalie.

- Since he arrived at the head of the Government of the Brussels-Capital Region in May 2013, Rudi Vervoort has given new impetus to governmental action. Keen to take up the challenges faced by the Region, the Minister-President has left his imprint on the Government of Brussels.
- His efforts in the last year of the 2009-2014 legislature convinced the denizens of Brussels, since they placed their trust in him in large numbers during the elections in May 2014. Rudi Vervoort will head the Government for the next five years. The Minister-President plans to continue to see through the projects he identified as taking priority in order to approve the daily life of the people of Brussels. The major stakes for the year to come include, by way of example, the demographic challenge, urban development, the improvement of the employment rate for the city's inhabitants, the development of multimodal mobility, the construction and renovation of housing units and the improvement of the Region's image in Belgium and abroad.

## LA MONNAIE / DE MUNT

Throughout history and under various regimes, Brussels has built up an identity of its own from the merging of peoples and cultures that rightly reinforces the city in its role as the capital of Europe. Likewise, its main theatre, inaugurated in 1700 and therefore one of the continent's oldest cultural institutions. opened its doors to the various European cultural movements that interwove with and succeeded each other Being the keystone of Belgian cultural life and, since the sixties, the heart of the international dance scene 1 a Monnaie again gained international acclaim in the world of opera under its director Gerard Mortier (1981-1991). This great increase in appeal was transformed into numerous coproductions and tours that only confirmed the prestige of the Brussels opera. Bernard Foccroulle (1992-2007) followed the artistic policies of his predecessor, enlarging the repertoire to include Baroque music and contemporary creation and inviting such leading artists as Sir Antonio Pappano, Anne Teresa De Keersmaeker and Philippe Boesmans. The current director Peter de Caluwe arrived in 2007. Whilst remaining faithful to the importance given bold theatrical approaches during the two previous decades, he nonetheless introduced new aesthetics and hired a new generation of directors and singers. This policy has elicited many accolades in the international press who keep La Monnaie within the top league of opera houses. Opernwelt, most notably, pronounced La Monnaie 'Best opera house of the year' in 2011. Today, more than ever convinced that a profound experience of opera, dance, concerts and recitals broadens the general awareness of human society and the human condition. La Monnaie is continuing to realise its role as an inclusive and open place of creation, serving all generations and communities.

### MARIE-NICOLE LEMIEUX CONTRALTO

After winning the Concours Reine Elisabeth singing contest in Brussels in 2000, Quebec contralto Marie-Nicole Lemieux built an international career and now sings on the world's most prestigious stages: La Scala, Royal Opera House Covent Garden, Opéra National de Paris, Théâtre des Champs Elysées, La Monnaie, Staatsoper Berlin, München and Wien, Zürich Opernhaus, Theater an der Wien, Teatro Real in Madrid, Liceu in Barcelona, Salzburg Festival, Glyndebourne Festival, Canadian Opera Company in Toronto and Montreal Opera.

Her powerful voice, her superb sense of line and a flawless virtuosity combined with her sense of nuance and drama allows her to triumph in various repertoires. The beginning of her career is marked by baroque music (Orphée by Gluck, Giulio Cesare, Ariodante, Orlando Furioso, Salomon, Theodora...). The evolution of her voice soon allowed her to take on the French repertoire of the XIXth century (Les Troyens, Pelléas et Mélisande, Samson et Dalila, Carmen...), Rossini (Guillaume Tell, Tancredi, L'Italiana in Algeri...) and also Verdi (Mrs. Quickly in Falstaff, Azucena in Trovatore, Ulrica of Ballo in Maschera...).

She is acclaimed as a peerless recital artist with an exceptional vocal palette having a special talent for French and Russian songs, as well as German lieder.

Her rich and varied discography has often been rewarded, and in 2017, Marie-Nicole Lemieux started a collaboration with Warner Classics.



## FILIP JORDENS CHANSONNIER

Theater director, singer and actor Filip Jordens (1975) graduated from the Studio Herman Teirlinck in 2000 with a master in variety entertainment. He performed his self composed theater monologue "La Mort de Muriël" at the festival Theater Aan Zee in Oostende. In 2002, he plays in Marius-La Trilogie by De Onderneming.

With his production Hommage à Brel, Jordens toured in Belgium, France, the Netherlands, Germany as well as Hong Kong, Dubai and Uganda. In 2004, Jordens performed his Brel program in the prestigious Berlin theater Bar Jeder Vernunft.

In 2011, he collaborated with composer / arranger Michel Bisceglia to create Brel

Symphonique with the Ghent University Orquestra. In 2013, he sang in front of an audience of 13,000 people in the Marollen area of Brussels during the Bal National and in 2017, he opened the cultural season with an open air concert together with the Antwerp Symphony Orchestra for 4,500 people.

In "Goddam! A Tribute to Dr. Nina Simone" (2004), Jordens sings, together with other vocalists, including Gregory Frateur and Tutu Puoane, songs by jazz legend Nina Simone. In 2009, he plays with the Nederlands Philharmonisch Kamerorkest in Le Carnaval des Animaux / Babar. The same year he collaborates with Björn Schmeltzer from Grain de La Voix to create Muntagna Nera.

Filip Jordens belongs to the artistic core of the company Bad Van Marie. In 2015, he interpreted Léon Degrelle in Le sec et l'humide by Guy Cassiers for Toneelhuis in Antwerp, a production that was shown during the 2017 Festival d'Avignon. Furthermore he performed or performs with Het Paleis, de Koninklijke Vlaamse Schouwburg, Luxemburg, Het Toneelhuis, Speeltheater Holland, Compagnie Marius, Theater Stap and many others.

Jordens can be seen in the feature film Lijmen/het Been by Robbe De Hert and in De Laatste Zomer by Joost Wynant, as well as in a series of short films and tv shows. He also works as an acting teacher for the Royal Conservatory in Antwerp.

2018 has a number of exceptional projects in store for Filip Jordens. He will be involved in the multimedia documentary symphonic concert Je m'appelle Jacques Brel in Vorst Nationaal in Brussels. Furthermore, he will interpret the titel role of Don Quichotte in a production of L'Homme de La Mancha in the Koninlijke Vlaamse Schouwburg and La Monnaie.
